It's time to claim!

Don't forget to make your declaration!

The NHS BSA website is now open for online declarations for Review Point One (28th April 2017). It will be open<u>until</u> <u>Friday 12th May 2017 at 23:59.</u> You must enter all the information required and submit the declaration by this date otherwise you will not be entitled to a Quality Payment.

Important: once you have submitted your online declaration it cannot be altered so it is imperative to check this thoroughly before submitting. Then please keep your confirmation email as evidence of submission.

For Info - Payments

For the first review point, payments to contractors will be made at the end of June 2017 and for the second review point, at the start of February 2018. Each point successfully achieved, will be paid at £64 per point for both review points. If the total funding available of £75m has not been paid to contractors after the second review point, remaining funds (up to a total of an additional £64 per point) will be redistributed as a reconciliation payment according to the total value of points claimed per contractor in the two declarations. Contractors will not be required to claim for this - it will automatically be paid out at the end of May 2018.

And then.....

.....you may breathe a sigh of relief and take a break from Quality Payments, but not for long! By the second review point (24th November 2017), you need to have these THREE criteria in place too (as well as the other initial five):

- Production of a written report that demonstrates evidence of analysis, learning and action taken in response to near misses and patient safety incidents, including implementation of national patient safety alerts and having shared learning (20 points)
- Results of patient experience survey from the last 12 months published on the pharmacy's NHS Choices page (5 points)
- Healthy Living Pharmacy level 1 (self-assessment) (20 points)

We will be issuing guidance shortly on how to meet these outstanding criteria in time for the November review point – although we know many of you have already published your CPPQ on Choices – great to see you so keen!!

Sexual Health Service Training (NYCC only)

You may recall the message we put out in early April from the public health team at NYCC, mentioning changes to the Faculty of Sexual and Reproductive Health guidance for emergency contraception (EC) in March 2017.

The existing PGDs do not accurately reflect this new information and so are currently being updated, along with

the PharmOutcomes templates. New training will need to be undertaken when these new PGDs are issued by all pharmacies delivering the service and the two dates and venues we have provisionally agreed with YorSexualHealth are:

PSNC wishes to inform community pharmacy contractors that it has identified issues with payments being made under the Pharmacy Access Scheme (PhAS) and is working with the Department of Health and NHS England to find solutions.

Since the introduction of PhAS, PSNC has been working to make sure that the scheme will operate in accordance with

PCSE Pharmacy Compensation Claims

NHS England has set up an email account to handle claims from community pharmacy contactors about losses they have incurred due to poor service from Primary Care Support England (PCSE).

This follows a range of issues that have arisen since Capita's takeover of the PCSE service contract in 2015, including delays in market entry decisions and late payments (e.g. pre-registration payments).
