Please find enclosed a form for you to complete to notify NHS England of your opening hours on forthcoming Public and Bank Holidays – Easter 2018.

Community Pharmacy is an important part of NHS system resilience and is promoted as first contact for many conditions and the elderly who are feeling "under the weather". Notification of intended opening hours allows NHS England to make an assessment of the adequacy of community pharmacy provision at a Health and Wellbeing Board level.

## Please Note:

- Saturday 31<sup>st</sup> March 2018 is a normal working day. Any pharmacy that normally opens on Saturdays must open as usual on Saturday 31<sup>st</sup> March 2018 unless it acquires permission from NHS England to change core\_opening hours or has given 90 days' notice of change to Supplementary hours.
- We would encourage all pharmacies to complete the attached form, however Pharmacies that do not complete and return the form will be assumed to be closed on all public and Bank holidays and open normal hours on all other days.
- Pharmacies who give notice of being open on Public and Bank holidays will have this information passed on to relevant organisations including CCGs, NHS111 and local newspapers
- NHS England has agreed a rota covering these bank holidays and those contractors will be required to open as directed
